- 2. The general nature and effect of the Orders will be to:
- (a) revise the parking charges at on street and off-street parking places (excluding the charges for permits) so that they would be based on vehicle bands, as set out in:
  - Schedule 1 Vehicle bands assigned by type and emissions produced or engine size;
  - Schedule 2 Revised charges for on-street parking places; and
- Schedule 3 Revised charges for off-street parking places (Council-run car parks).
- (b) remove the option for the parking charge to be made using "Pay & Display" as a method of payment. All existing "Pay & Display" machines will be withdrawn;
- (c) make provision for payment of the parking charge to be available at "PayPoints" using cash (as an alternative to payment by debit or credit card). PayPoints will be available at various retail premises throughout the borough; and (d) make minor changes to the 'parent' Orders to ensure that they reflect the current provisions.

Note: [This notice is about the continuation of a low traffic neighbourhood in the area known as the Oval Triangle. This will include introducing contra-flow cycle lanes and reversal of part of the one-way system in Palfrey Place, banning vehicles in Elias Road entering Claylands Place and a compulsory left turn into Claylands Road, introducing point no entries in parts of Claylands Road and Dorset Road and bans on vehicles entering or exiting parts of Albert Square, Dorset Road and Richborne Terrace and changes to parking places in Clavlands Road and Elias Place. - (d) ban vehicles, except pedal cycles, proceeding in a south-easterly direction in Dorset Road from entering that length of Dorset Road which lies 22 metres south-east of Cobbett Street:

- (f) ban vehicles, except pedal cycles, proceeding in a south-easterly direction in Claylands Road from entering that length of Claylands Road which lies south-east of the north-western kerb-line of Claylands Place;
  (g) ban vehicles, except pedal cycles, proceeding in
- Claylands Road from turning left into Palfrey Place; (h) ban vehicles, except pedal cycles, proceeding in
- Claylands Road from turning left into Claylands Place (i) ban vehicles, except pedal cycles, proceeding in Claylands Place from turning right into Claylands
- (j) ban vehicles proceeding in Elias Place from entering Claylands Place;
- (k) reduce a length of the shared use residents' and pay and display/pay by phone parking place outside No. 10 Claylands Road by 2 metres and replace it with double yellow lines;
- (I) reduce a length of the shared use residents' and pay and display/pay by phone parking place outside No. 7/9 Claylands Road by 5 metres and replace it with double yellow lines; and
- (m) suspend and remove a disabled persons' parking place outside No. 7 Elias Place and install a new disabled persons' parking place in Claylands Road at the side of No. 26 Clapham Road. The parking place would operate at any time and be for the use of vehicles displaying a disabled person's "blue badge"

### CONTINUATION OF A MANDATORY CYCLE LANE IN THORNE ROAD, INITIALLY TRIALLED AS AN EXPERIMENT CONTINUATION OF CYCLE LANE PROVISION

INOTE: This notice is about the mandatory cycle lane in part of Thorne Road, which has been in force by an experimental order but will now be continued indefinitely by the new order described below.]

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth on 23rd February 2022 made the Lambeth (Cycle Lane) (No. 2) Traffic Order 2022 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Order will come into force on 28th February 2022 and it will continue indefinitely the provisions of an experimental order that is currently in force.
- 2. The general effect of the Order will be to continue the mandatory cycle lane on the north side of Thorne Road from a point 12 metres west of the western kerb-line of South Lambeth Road westwards for a distance of 15 metres. The cycle lane is physically segregated from the rest of the carriageway and all vehicles, except pedal cycles, are banned from being driven or ridden in the cycle lane at any time.
- 3. The Order is necessary because of an increase in the number of pedal cyclists travelling along the road which is part of Cycleway 5. The Order will be effective at certain times from 12:01 AM on 6th March 2022 until 11:59 PM on 5th September 2023 or any further order made comes into effect, whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- 4. The prohibitions will not apply in respect of:
  - any vehicle being used for the purposes of for the purposes of those restrictions or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
